

DES Continues to Gather Opinions on Lake Level

On August 17, DES held a second hearing at Church Landing in Meredith to solicit public comments on the interim operating level, after which, a final operating level decision will be issued by the department.

In April, DES made a decision regarding an interim operating plan that determined the water level should be maintained at 539.5 feet above sea level for the recreational season (mid-May though Nov. 1). The plan also calls for the level to be gradually low-ered to a level of 538.0' after Nov. 1.

At the meeting DES representatives discussed the techniques used during the study and tried to clarify how they reached their decision for the interim plan. Jody Conner, Limnology Center Director at the Watershed Management Bureau, addressed the water quality concerns and the affect water levels and shoreline erosion can have on the health of our lakes.

DES will continue to accept written comments until Sept. 30. Letters may be sent to the New Hampshire DES, Attn: Dam Bureau, P.O. Box 95, Concord, N.H. 03302-0095. DES also has an online survey available at www.surveymonkey.com/s/9NPK88G (one survey per household).

We will continue to monitor the progress of the interim plan and will keep everyone informed as developments occur. We will also continue to monitor the status of the beaver activity on the snake river.

Local Survey Gathers Opinion


On July 25th, Penny Burke, Mary Walker and Althea Dunscombe began a survey of property owners regarding the water level of Lake Winona and how they viewed the "summer recreational level" set by DES. Their goal was to provide DES with a comprehensive survey that would offer an accurate overview of the sentiment of Lake Winona property owners. The survey was also designed to give 100% of property owners the opportunity to voice their opinion.

Among the 105 property owners surveyed (only one survey was allowed per property), 23.8% were satisfied with the 539.5' level or wanted a lower level, while 68.6% were for a higher level or were satisfied, but willing to compromise for a higher level of at least 6 more inches. Responses were not provided by 7.6% of property owners. Among respondents, 60% do not favor a fall draw down this year.

This survey was concluded on

September 18. All original surveys and tabulated results were delivered to Steve Doyon at DES, with copies provided to Don Thibeault. Anyone wishing to view the individual surveys or receive a copy of the results may contact Don.

Water Skiing Navigation Rule Challenged

According to the NH Boating Safe Passage Requirements, "You may not operate a vessel or ski at a speed over six mph within 150' of the shoreline."

For as far back as most residents can remember, the counterclockwise navigation rule, which was developed by lake residents over 25 years ago to maintain safe distance among the large number of skiers on the lake, has been adhered to by owners and "respected" by Marine Patrol.

This summer, however, some boaters were stopped by Marine Patrol and told they could not ski/tube between the island and the point because there was not enough distance. Instead, they would need to ski in both directions between the island and the Winona Rd shoreline.

While today there are only a handful

of ski boats on the lake, the ability to maintain the counterclockwise navigation ensures continued safety, particularly if multiple boats are pulling skiers at the same time.

Apparently there is no official exception to the regulation, and some owners have indicated that LWIA should work with Marine Patrol to establish an official

exception supporting the continued counterclockwise navigation for safer skiing and tubing.
